

When we heard the incredible success [The Connection, Inc.](#) has had using EyeDetect for Connecticut State and Federal Probation to test those who have committed sex offenses, we knew this story had to be shared. The Connection is a nonprofit organization based in Middletown, Connecticut. After two successful pilot programs of EyeDetect in 2017 and 2020, EyeDetect proved itself an invaluable tool and was fully implemented. They've now administered more than 1,500 tests and discovered EyeDetect offered numerous benefits, namely:

- The test is automated and can be administered with limited contact between examiner and client, an important issue during the pandemic.
- More tests can be administered daily than with previous tools.
- Investigations to validate client complaints of inaccurate polygraph test results have been minimized.
- Clients previously unsuitable for polygraph due to medical or mental health restrictions are tested.
- EyeDetect's testing protocol makes it easier for the examiner to identify when a client is being purposefully noncompliant (trying to cheat).

EyeDetect has clearly helped The Connection's community-based treatment programs more effectively prevent sexual abuse and reduce sexual violence.

I want to personally thank Erika Thiel, LPC, the credibility assessment manager at The Connection Inc., for allowing us to share their story. Erika is a licensed professional counselor, a polygraph examiner trained in post-conviction sex offender testing (PCSOT), and an approved PCSOT instructor.
